### **RECOMMENDATION**

Adopt a Resolution of the City Council of the City of Mountain View Authorizing the Temporary Closure of Parking Lot No. 11 from 7:30 a.m. through 3:30 p.m. on Sunday, May 19, 2024, for Use by the City of Mountain View Fire Department to Support the 150th Year Parade and Celebration, to be read in title only, further reading waived (Attachment 1 to the Council report).

#### **BACKGROUND AND ANALYSIS**

The Mountain View Fire Department was established on April 1, 1874 and will be celebrating 150 years of service in 2024. To celebrate the sesquicentennial, the Mountain View Fire Department is collaborating with neighboring fire and police departments to celebrate the milestone with a planned parade down Castro Street, a recruitment fair, and celebration occurring at the Mountain View Civic Center Plaza on Sunday, May 19, 2024. A parade of vintage and modern fire and police vehicles will travel a parade route that begins at the Police/Fire Administration Building at Franklin and Villa Streets down Castro Street towards the Mountain View City Hall. The parade will start at 12:30 p.m. and conclude at approximately 1:30 p.m. The celebration at Civic Center Plaza will have a variety of public safety booths, vehicle exhibits, and family activities concluding at 3:00 p.m.

To accommodate visiting fire apparatus, Parking Lot 11 (Figure 1) will be used to stage parade vehicles before and after the parade.
