5.1 2022 AB 481 MILITARY EQUIPMENT ANNUAL REPORT

Police Captain Mike Canfield presented this item.

- How many Officers accompany the command vehicle?

- Does the Mountain View Police Department (MVPD) use tasers?
- Can you confirm that Officers have not fired a gun in the last year?
- What items from the list of military equipment would be on the MVPD wish list?
- In the last five years, is there any equipment utilized through mutual aid with other cities that the MVPD should probably have?
- Is the standard-issue shotgun considered military equipment?
- What type and how many rifles are the MVPD considering getting to replace the ones being returned as surplus military equipment?
- What are the applications of the new drones? Is it to read license plates or use facial recognition? What is the process for the MVPD to use a drone in a way it has not before?
- Give some examples of when canisters and other skin irritants would be used.
- Explain the comment in the memo about mitigating against price increases for ammunition.
- Why does the MVPD buy .223 instead of .556 ammunition?
